The contractor should have documentary proof of having undertaken such Projects and have executed successfully at least three similar nature of work for the last five years to the tune of Rs 15 lacs or four similar works costing not less than 10lacs each for which bidders must submit proof including client references, order value and performance certificates.

The Bids shall be deposited in electronic format on the departmental website [www.iktenders.gov.in](http://www.iktenders.gov.in) from in two covers Viz. Pre-Qualification / Technical Bid and Financial Bid.

**I) Cover 1<sup>st</sup> Shall contain**

- a) Scanned copies of EMD and Tender document cost.
- b) Latest GST certificate
- c) Documentary proof of having undertaken such projects on turnkey basis and have executed successfully at least three similar nature of work for the last five years to the tune of Rs.15lacs or four similar works costing not less than 10lacs each for which bidders must submit proof including client references, order value and performance certificates.

**II) Cover 2<sup>nd</sup> shall contain:**

- a) Financial Bid

- b) Pre-qualification/Technical bid shall be accompanied with cost of tender document in shape of demand draft in favour of Managing Director J&K State Agro Industries Corporation Ltd Earnest money /Bid security/ in shape of CDR/FDR pledged to Managing Director J&K State Agro Industries Corporation Ltd.
- c) The bids for the work shall remain valid for a period of 180 days from the date of opening of bids.
- d) The pre- qualification/ Technical bids uploaded on the website upto due date and time will be opened on due date in the office of Managing Director J&K State Agro Industries Corporation Ltd. in case of holidays/office happens to be closed on the date of opening of the bids , bids will be opened on the next working day at the same time and venue.
- e) The complete bidding process will be on line.
- f) The Financial bid shall be opened online in the office of Managing Director J&K State Agro Industries Corporation Ltd at Lal Mandi Srinagar after evaluation of pre-qualification/ technical bid.

**III ) The earnest money shall be forfeited, if:**

- a) Any bidder/enderer withdraws his bid/tender during the period validity or make any modifications in the terms and conditions of the bid.
- b) In case contractor fails to execute the agreement within 15 days after fixation of contract.

**IV) Instruction to bidders regarding e tendering process:**

- a) Bidders are advised to download bid submission manual from the downloads option as well as from bidders manual Kit on website [www.jktenders.gov.in](http://www.jktenders.gov.in) to acquaint bid submission process.
- b) To participate in bidding process, bidders have to get Digital Signature certificate (DSC) as per information technology Act-2000. Bidders can get Digital certificate from any approved vendor.
- c) The bidders have to submit their bids online in electronic format with digital Signature. No Financial bid will be accepted in physical form.
- d) Bids will be opened online as per time schedule mentioned in the NIT  
Bidders must ensure to upload scanned copy of all necessary documents like CDR/PAN/TIN/Demand draft/technical. All Pre-qualifications documents from successful bidder in original shall be submitted to Executive Engineer Directorate of Agriculture Kashmir.

Note: - scan all documents on 100dpi with black and white option.

- V)** The department will not be responsible for delay in online submission due to any reasons.
- VI)** Scanned copy of cost of tender document in shape of demand draft in favour of Managing Director J&K State Agro Industries Corporation and the earnest money/ Bid Security in shape of CDR/FDR as applicable pledged to of Managing Director J&K State Agro Industries Corporation must be uploaded with the bid.

**VII)** Bidders are advised not to make any change in BOQ (bill of quantities) contents. In no case they should attempt to create similar BOQ manually. The BOQ download should be used for filling the item rate inclusive of all taxes and it should be saved with the same name as it contains.

**VIII)** Prices.

- a) The unit rates and prices shall be quoted by the bidder entirely in Indian Rupees and the rates quoted shall be deemed to include price escalation and all taxes upto completion of the work unless otherwise, specified.
- b) If the bidder does not quote rate for any item of the price bid, the item shall be deemed to be the part of the overall contract value and no rate shall be allowed for such item.
- c) In case bid of the lowest bidder is found unbalanced. The bidder shall have to deposit additional amount as indicated below.

**IX)** Bidders are advised to use My Documents area in their user ID on JK e-tendering portal to store such documents as are required.

**X)** The cost of tender document is non refundable and the tender shall in no case be accepted if submitted by any firm other than the purchaser.

**XI)** Any tender found to have been submitted by the firm by furnishing false information to the department shall be cancelled and the firm shall be penalized as and when it comes to the notice of the Department even during the currency of the contract.

**XII)** Before quoting, tenderer's are requested to visit the site of work.

**XIII)** The photocopies of all documents to be submitted physically by the successful tenderer shall have to be Self Attested by the proprietor/ authorised signatory of the Firm without which they shall not be accepted.

**XIV)** All civil suits/ legal remedy/arbitration in connection with the contract shall be subject to jurisdiction of courts of J&K State (Srinagar City ) and governed by provisions of the J&K state arbitration Act 2002 and the rules there as under and any statutory modifications shall be deemed to apply to arbitration.

**XV) Payments.**

The payment shall be made to the tune of 80% after successful completion testing and commissioning of the work. The remaining 20% shall be released only after successful completion of defect liability period (DLP) of one year.

Alternatively the agency can submit a bank guarantee from any nationalized bank covering the cost of any liabilities arising due to defects or faults during the DLP for release of the 20% amount.

- XVI)** The successful bidder has to deposit all manuals, guarantee card, manufacturer test certificate, Earthling test certificates of all the equipments from the competent authority and all other relevant documents in respect of the equipment and items installed.
