


TERMS AND CONDITIONS FOR LABOUR CONTRACTOR

The terms and conditions with details of operations to be conducted by the Labour Contractor during the Year 2016-17 are as under:-

1. The Labour Contractors having a minimum experience of 10 years in the field of Production and also having GST No allotted in their favour alongwith the Certificates of the firm or Factory with whom they have been Working in the past.
2. The approved Labour Contractor shall have to work and provide Labour for conducting various operations in all the 1/2 Shifts on daily basis.
3. The various operations to be expected from the labour are as under:-
 - (a) Unloading and Stacking of all the incoming Raw Materials.
 - (b) Feeding of Raw Material in the Plant.
 - (c) Bagging and Weighment of Finished products.
 - (d) Stocking / Stacking and Shifting of finished goods to the stores.
 - (e) Loading of finished goods for despatches from the factory.
 - (f) Refilling of leaked/Scattered Raw Materials into the bags again per Qtl.
4. The Labour Contractor shall have to Quote the rates for all operations as above on Quintals basis and shall have to attach a C.D.R for Rs. 50,000/- (Rupees Fifty Thousand Only) pledged to General Manager Cattle Feed Plant , J&K State Agro Industries Development Corporation Ltd. Bari Brahmana, Jammu. The CDR of the Successful tenderers shall be released subsequently. In the absence of CDR the offer may not be entertained.
5. No "DALA" charges or any other charges what so ever shall be paid by Govt / Corporation Trucks / Load Carriers and the Labour Contractor shall have to provided Labour as per the requirement of the production wing within 5 days time from the date of allotment of the contract and thereafter shall have to maintain regular availability of Labour on day to day basis as per actual requirements for running the factory in 1/2 shifts (Minimum 13 Labourers).
6. Income Tax as applicable shall be deducted at the source from each bill while releasing the payments. The payment shall be released on fortnightly basis.
7. The validity of the contract shall be initially for a period of 12 months which can be extended on mutually agreed terms subject to satisfactory performance.
8. In case the Labour Contractor fails to provide timely labour, the Corporation shall be at liberty to arrange labour from the open market for maintaining the continuity in the production and losses if any incurred shall be recoverable from the Contractor.
9. In case the Corporation establishes that default has not been due to genuine reasons the Corporation shall be at liberty to terminate the contract after giving 7 days notice.

10. In case of any dispute the same shall be referred to the Managing Director, J&K State Agro Industries Development Corporation Ltd. Who shall also act as an arbitrator and his decision whatsoever shall be a final binding on both the parties.
11. The Civil Courts of Jammu alone shall have the Jurisdiction to settle legal cases.
12. The undersigned shall reserve the right to accept or reject any or all tenders without assigning reasons thereof.
13. The Labour Contractor shall have no claim what so ever during normal breakdown / maintenance programmes power failures.
14. The successful Labour contractor shall have to execute an agreement for the successful execution of the contract incorporating all the above terms.
15. In case the rate quoted are very low as compared to the present market rates and the committee feels that the contractor may not be in a position to provide adequate Labour in time on such rates and our factory work would suffer the committee shall reserved the right to reject such offers without assigning any reasons thereof in the best interest of our production targets.
