2. Warranty: - The equipments shall carry comprehensive warranty for 24 months from the date of sale against any manufacturing defect and satisfactory performance. In case of any complication / defect, the down time shall not exceed three days and in the event of failure, the same shall be got repaired from some other source at your risk and responsibility. The equipment shall have to be replaced within 15 days in-case of manufacturing defect.
3. Delivery: - As the supplies are time bound, the material duly packed as per provisions be supplied within 10 days positively.
4. Payment: - 100% payment shall be released within 10 days after receipt of payment and verification from the indenting department.
5. Security: - 2 % of the value of the equipment in the shape of cheque be deposited as security.
6. Order Acceptance: - Acceptance of the order to be conveyed within one day.
