

The last date for submission of tender is 26 -12--2017 upto 3 pm. There should be no cutting or overwriting in the offer. The tenders will be opened on the same day at 3:30 pm or any other date convenient to the Committee Members.

- Manpower provider should be a registered agency having registration with labour Department and othe relevant Agencies.
- The manpower provider should have valid licence for operation of such service.
- The Agency should have experience in manpower providing field for atleast of 2 years or more.
- The Company should have vaild Pan Card No. of Income Tax Department . Service Tax registration and contract Licence .
- The Company as an employer should comply with all the statutory requirements such as payment of Gratuity Act, ESI, P.F & GST extra as applicable to them.



2. Service Tax and other taxes wherever applicable should be stated in the tender separately.
3. Rate should be quoted for duty of 8 hours a day .
4. Rates are to be mentioned both in figures and words and covered with transparent tape.
5. The M.D J&K State Agro reserves the right to accept or reject any quotation in full or part.
6. After engaging the services of the Agency,if it is found that the service are not rendered to the satisfaction of the Corporation , the services will be terminated without paying any damages/compensation to the Agency during the term of contract.
7. After selection of the agency, the Agency shall execute an agreement on stamp paper.
8. J&K State Agro Industries Development Corporation Limited reserves its right to reject, accept or cancel the process of selection without assigning any reason thereof.
9. Any dispute arising out relating to this tender shall be subject to adjudication of competent Court in Jammu & Kashmir.
10. Any tender not complying partly or wholly with the terms and conditions shall be liable for rejection.
11. In the event of any loss/damage occurring to J&K State Agro Industries Development Corporation Limited on account of the negligence of the manpower provided by the Agency, the Agency shall make good the loss sustained either by the replacement of the material/equipment or payment of compensation.
12. Either party can terminate this agreement by giving one month's written notice to the other side without assigning any reason and without payment of any compensation thereof. However, J&K State Agro Industries Development Corporation Limited shall give only a 24 hours notice for termination of this Agreement to the manpower providing Agency when there is a major default in compliance of the Terms and Conditions of this Agreement or the Agency has failed to comply with its Statutory obligations. In that eventuality the agency will move out of our premises immediately.

13. The Agency shall raise the bills for payment of wages on 3<sup>rd</sup> of every month so that the same is cleared within 1<sup>st</sup> week of every month in favour of the Agency. However the Agency shall ensure the release of wages in favour of the manpower provided on 3<sup>rd</sup> of every month.
14. To safe guard its interest, Corporation reserves the right to include other terms and conditions in the agreement at the time of execution of agreement.
15. The dispute arising out of the contract shall be settled through arbitration and Managing Director, J&K State Agro Industries Development Corporation Limited shall be the sole arbitrator.
