For and on behalf of the Lt. Governor of J&K UT, term e-tenders (in single cover system) are invited for the interested persons / parties for **Auction of scrap items of JKAIDCL**, for the year **2024-25**. The Minimum reserved bid is fixed as of each item in Annexure II of this NIT.

1. The date and time of opening of bids shall be notified on website

www.jktenders.gov.in. The bids of the responsive bidders shall be opened online on the same website in the office of the Cattle Feed Plant, Bari Brahmana, Jammu.

2. The bids for the tender shall remain valid for a period of 120 days from the date of opening of bids.
 3. **Bids must be accompanied with cost of tenders' documents in shape of Bank Receipt in f/o J&K Agro Industries Development Corp. Ltd bearing J&K Bank Acc No CD-0097010100000962, IFSC Code- JAKA0TNHALL, Earnest money/bid security in the shape of CDR/FDR Pledged in favour of Managing Director J&K Agro Industries Development Corporation Limited.**
 4. If any question, dispute or difference what so ever, arises between the firm & the deptt./ Government in relation to or in connection with this contract either of the parties may give notice in writing of such questions, dispute or difference and the same be referred to the Administrative Secretary of the Department for arbitration. This submission shall be deemed to be a submission to arbitration within the meaning of the Jammu & Kashmir Arbitration Act. In witness thereof the parties here to have signed this agreement on the dates respectively mentioned against their signatures. The provision of J&K Arbitration Act Samvat 2002 and of the rules there under and statutory modification thereof shall be deemed to apply to the arbitration disputes if any regarding reference to courts shall be subject to jurisdiction of J&K courts only. If there is any deviation from the specification of the product (test reports), all the penalties in such case will be applicable on the bidder only.
 5. Authority has the right to cancel the tender without assigning any reason at any time of during the contract period.
 6. The rates to be quoted item wise.
 7. In case the successful bidder becomes defaulter the CDR will be forfeited
 - a) Bidders are advised to download bid submission manual from the "Downloads" option as well as from "Bidders Manual Kit" on website www.jktenders.gov.in to acquaint bid submission process.
 - b) To participate in bidding process, bidders have to get „Digital Signature Certificate (DSC)" as per Information Technology Act-2000. Bidders can get digital certificate from any approved vendor.
 - c) The bidders have to submit their bids online in electronic format with digital Signature. No financial bid will be accepted in physical form.
 - d) Bids will be opened online as per time schedule.
 - e) Bidders must ensure to upload scanned copy of all necessary documents with the bid.
- Note: - Scan all the documents on 100 dpi with black and white option.
8. The department will not be responsible for delay in online submission due to any reasons.
 9. The Bidder must have to upload (soft copies) of the following documents (Photostat/Original should be clearly seen in all respect with Ink Signed and Seal):-

11. The Bidder should upload the Tender Document form attached below (Not Mandatory).
12. Bidder must ensure to upload scanned copies of all necessary documents including
 - Valid Bank Receipt (COD) and Call Deposit Receipt (CDR)
13. The Highest Bidder will have to submit hard copies of all documents uploaded on e-tending portal before issuance of Allotment.
14. The successful bidder shall have to deposit the full amount before lifting the scrap material.
15. If the bidder quote highest rate for maximum items in the BOQ then all the leftover items also be rewarded to such bidder.
16. All the scrap items shall be weighted on weighing machine of Cattle Feed Plant Bari Brahmana.
17. The bidder shall bear loading of the scrap and transportation from the site of Cattle Feed Plant.
18. Before proceeding for bid submission, the bidder has the right to visit the site at Cattle Feed Plant, Bari Brahmana and check the scrap items as per BOQ.
